## airasia Superapp Complimentary Voucher Terms & Conditions

### Introduction

- 2. This provision of this Voucher is governed by the specific terms and conditions set out hereunder ("Terms and Conditions") and by receiving and utilizing this Voucher, you agree to be bound by these Terms and Conditions, the Terms of Carriage available on airasia.com and shall be deemed to have given your consent for the collection of personal information and the use of such personal information shall be in accordance with the Privacy Policy of the Organiser with no monetary payment.
- 3. Information on how to utilize this Voucher forms part of these conditions of redemption. Redemption of Voucher is deemed as acceptance of these conditions of redemption. Acceptance of these Terms and Conditions is a condition of redemption.
- 4. The Voucher can only be redeemed at www.airasia.com However, you advised to register as an AirAsia member before the redemption.

## **Validity**

5. Subject to the terms and conditions contained herein this voucher is only valid for use on or before the date stated for the redemption of AirAsia seats ("Voucher Validity Period"). The voucher holder ("Holder") does not need to be a passenger on the flight ("Passenger") of any voucher redeemed.

# **Specific Terms and Conditions**

- 6. Each seat shall be for the sector stated on the Voucher. Any requests to change sector(s) or seat(s) are strictly not allowed and will not be entertained.
- 7. Both travel and redemption periods must be within the Voucher Validity Period (outgoing and return flights must be completed within this period) the Voucher is non-refundable, non-transferable and non-exchangeable for any other benefits in kind.
- 8. The Voucher Validity Period cannot be extended. Any Voucher not redeemed within the validity period shall be deemed surrendered and forfeited. There will be no extension given once the Voucher Validity Period has expired.
